

Prerequisites

All are welcome to attend the workshop, regardless of experience. However, the following prerequisites are highly recommended for those who intend to take the SAFe® 4 Product Owner/Product Manager (POPM) certification exam:

- Attend a Leading SAFe[®] course
- Experience working in a SAFe environment
- Experience with Lean, Agile, or other relevant certifications

Exam Details

- Exam format: Multiple choice
- Exam delivery: Web-based (single-browser), closed book, no outside assistance, timed
- Exam access: Candidates can access the exam within the SAFe Community Platform upon completion of the SAFe 4 Product Owner/Product Manager workshop
- Exam duration: Once the exam begins, candidates have 90 minutes (1.5 hours) to complete the exam
- Number of questions: 45
- More Exam Details
- Passing score: 35 out of 45 (78% passing score)
- Language: English
- Exam cost: First exam attempt is included as part of the workshop registration fee if the exam is taken within 30 days of workshop completion. Each retake attempt costs \$50.
- Retake policy: Second attempt on exam (first retake) can be done immediately after first attempt. Third attempt requires a 10-day wait. Fourth attempt requires a 30-day wait.
